Recently, a young dentist questioned whether he should renew his membership in organized dentistry. He stated that he was frustrated with the dental hygienist shortage, diminishing reimbursements of insurance companies, and insurance companies determining the standard of care based purely on economics. I agree with his frustration. He did not feel that organized dentistry was doing enough to address these issues.

First, I am thankful and glad that this dentist expressed his views. If he had just not renewed his membership, we would not have had the opportunity to speak with him. He would have been lost forever. Also, it is only through dialogue that we keep organized dentistry on the proper path, and we, dentists, understand why our leaders pursue the actions that they do.

Many columns have been written at the local, state, and national levels proclaiming in great detail all the benefits of organized dentistry. I will not rehash everything that organized dentistry does. This column is too short for that. I will list just a few items such as free insurance contract analysis, free complete regulatory compliance guide, a platform to support in-office membership plans, an independent means of appeal with a major dental insurance provider, free continuing education opportunities, and a new group purchasing organization. The monetary value of just these few benefits will greatly outweigh the cost of your dues.

As depressing as things may seem with respect to dental rules, regulations, and insurance companies, I can assure you that they would only be worse without organized dentistry. A representative from the Ohio Dental Association is present at every Ohio State Dental Board meeting. All the rules governing the practice of dentistry, expanded functions duties, CE requirements, compliance, advertising rules, etc. would be much more onerous without organized

dentistry. Please don't think this does not affect you. As someone who attends the board meetings, not as a representative of the ODA, some of you are breaking these rules and don't even know it. Thank the ODA for arguing on your behalf.

Legislatively, organized dentistry has won many, but not all, battles. Again, I will mention

just a few. Several years ago, tort reform reduced the statute of repose, thereby decreasing the number of years dentists had to retain patient records, and has also helped to keep dentists' malpractice premiums low. There still are no mid-level providers in Ohio. Through the ODA's diligence, Ohio is seriously considering passage of legislation that would prohibit insurance companies from setting fees for non-covered services. In the mid 1990's, the EPA tried to mandate and dictate the rules concerning amalgam separators for our fellow dentists in the northern part of the state. After years of educating and working with regulatory agencies, the ODA and ADA were able to formulate the rules that we currently have. These rules are much more palatable and the price of amalgam separators has been greatly reduced and the technology is better. All this is a

direct result of organized dentistry. For every terrorist attack the U.S. suffers, the Department of Homeland Security has stopped thousands that we don't hear about. Similarly, we hear about the few battles that organized dentistry loses, but we never hear about or realize all the hazardous, precarious, difficult, and burdensome, rules and regulations they have defeated.

Finally, if I still haven't convinced you, I will employ

January, 1934

Dear friend:

You are aware that health is a necessity, and nothing in the human body plays a greater part in maintaining good health than sound teeth. Poorly masticated food causes overwork in the rest of the digestive system and failure to distribute nutrition sufficiently to maintain the maximum of physical energy.

At the same time, decayed and infected teeth develop poison, which if continuously taken into the system with the food eaten or with the saliva swallowed, deadens certain bodily functions so that they fail to perform their purpose, viz., to supply nutrition to the various parts of the body and afterwards to carry away the refuse and exhausted material so that bodily health is preserved.

Millions of dollars are spent in treating cases of rheumatism, indigestion and kidney diseases that are traceable to the teeth. The mouth offers the one and only chance to protect the system. Nature does the rest without personal control. This job over which you have control should therefor be efficiently performed.

## President's Address (continued)

an argument that my dear mother used to use on me. I had the greatest mom in the world. I still think about her every day. However, whenever she could not convince me to do something, her final tool was the "guilt card."

I remember many years ago when I was new to the Ohio House of Delegates. Even then, when our market share was well over 70%, members were discussing how to attract and retain members. There was an oral surgeon from northern Ohio, who is retired now but still around, stood up and said, that as far as he was concerned, any practicing dentist who is not a member of organized dentistry is "scab." He is reaping all the benefits and hard work of organized dentistry, but not sharing in any of the burden.

The people who need organized dentistry the most are dentists at the beginning or middle of their careers. Those of

us at the tail end of our careers can weather any storm that legislators or insurance companies throw at us. We don't have families to support anymore or children to put through college. And if things get really bad, we'll just retire. We are the ones who don't need organized dentistry but we have a duty to support it as did all the dentists who came before us. I know dues may seem like a lot of money. However, if your practice grosses \$150,000, \$1500 is only one percent. If your gross is more than \$150,000, your dues cost less than one percent of your gross. If you have a young family you probably spend more than this on McDonald's or your morning coffee in a year.

So when someone says, how can I afford to belong to organized dentistry, my question to them is, how can you not afford to belong to organized dentistry?

Dr. Crossley has co-authored several articles and four books dealing with a variety of topics within the field of pharmacology. Other areas of expertise include the pharmacology of street drugs and chemical dependency. He serves on the Maryland State Dental Association's Well-Being Committee, is an active member of Phi Kappa Phi, Omicron Kappa Upsilon Honorary Dental Society, the American College of Dentists, International College of Dentists, and an honorary member of the Thomas B. Hinman Dental Society. He was the recipient of the 2008 Gordon Christensen Lecturer Recognition award presented by the Chicago Dental Society and the recipient of the 2012 Award of Distinction presented by the Academy of Dentistry International for his efforts in Continuing Dental Education. ***How long do I have to keep my dental charts?***

The Supreme Court of Ohio recently upheld the constitutionality of the state's four-year statute of repose in medical and dental malpractice actions. A statute of repose is a provision that sets a time frame in which a legal right extinguishes. In other words, the statute of repose places an effective time limitation on when dental malpractice suits may be filed against a treating dentist. Ohio's statute of repose bars actions filed more than four years after the date of treatment, except in the case of those patients who are mentally infirm and with minors, in which case the four years begins to run upon emancipation.

Dentists had previously been instructed to retain patient records indefinitely to aid in the defense of a lawsuit. However, this favorable court ruling may help relieve dentists' record-keeping burden. There may be circumstances where a dental office must maintain records for a certain period of time; for instance, the retention requirement for Medicaid records (6 years) and Medicare records (7 years). Participating provider agreements also generally specify record retention requirements, as well as many professional liability insurance agreements. Dentists are encouraged to obtain guidance from legal counsel and their malpractice insurer prior to the disposal of any patient records and to seek guidance on establishing a new record retention policy.

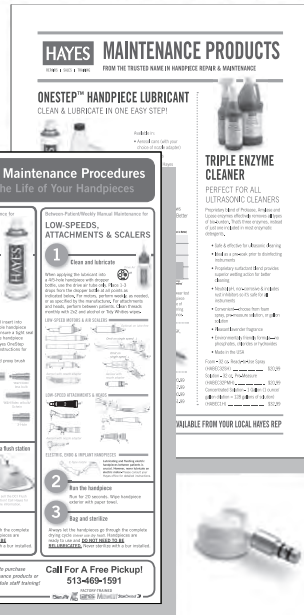
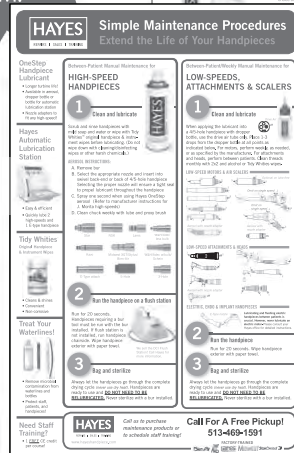

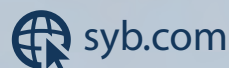
