President's Address

I'm fine. How do you feel?

I believe it is time to

get back to feeling,

to get back to

being together.

Are you ever in your office with patients and staff and feel lonely? In his July newsletter Dr. Bennet, our past president, wrote about mentorship. He said, "We work alone so much of the time, isolated from other people who are experiencing the same issues we are, and we can lose the perspective that comes with those relationships."

In other words, you are not alone! In these times, it is common to feel burnt out, tired and frustrated. As dentists, we are used to putting on a smile for everyone. We feel the need to keep our staff happy, so they stay with us, our patients happy so they give



I promise we will make you feel better and more excited to bring positive change to this gratifying profession.

Awarded the PIONEERS IN DENTISTRY from the American University of Beirut as the third recipient ever bestowed this honor. Dr. Massad was also awarded LIFETIME ACHIEVEMENT AWARD from the American Academy of Implant Dentistry for outstanding vision, dedication, and commitment to the field of implantology. Currently, he holds faculty positions at Tufts University School of Dental Medicine in Boston, Mass; the department of Comprehensive Dentistry at the University of Texas Health Science Center Dental School in San Antonio, TX; Adjunct Associate Professor, Department of Restorative Dentistry, Loma Linda University, Associate Professor in the Department of Prosthodontics, the University of Tennessee Health Science Center, College of Dentistry, Memphis, Tennessee, Clinical Assistant Professor, University of Oklahoma College of Dentistry, Oklahoma City, OK and the University of Texas Health Science Center, Houston, Texas. He has previously held a faculty position at the Oklahoma State University College of Osteopathic Medicine Oklahoma, is a past Director of Removable Prosthodontics at the Scottsdale Center for Dentistry in Arizona (2006 to 2010), from 1992 to 2003 was an associate faculty at the Pankey Institute in Florida. Recipient of Chicago Dental Society, "Gordon J. Christensen Recognition Lecturer Award", and awarded Lifetime Achievement Award from the American Association of Implant Dentistry in 2019.

"Unraveling Trigeminal Neuralgia" A Neurosurgeon's Perspective

Speaker: Ronald E. Warnick, MD Neurosurgeon, Mayfield Brain & Spine Co-Director, Gamma Knife Center, Jewish Hospital

This program will include a discussion of the causes of trigeminal neuralgia and common clinical presentations including typical and atypical subgroups. A comprehensive review of medical and surgical treatment options will follow. The presentation will conclude with important considerations for the practicing dentist, endodontist, and oral surgeon.

About the Speaker:



Ronald E. Warnick, M.D., is a neurosurgeon and brain tumor/trigeminal neuralgia specialist with Mayfield Brain & Spine in Cincinnati. He earned his medical degree with honors from the University of Rochester, completed his neurosurgery residency at New York University, and performed a neuro-oncology fellowship at the University of California, San Francisco. He was a faculty member at the University of Cincinnati (UC) from 1991 to 2017, becoming a full professor in 2001. He held the John M.

Tew, MD, Chair in Neurosurgical Oncology and for ten years was Medical Director of the UC Brain Tumor Center. He is currently Co-Director of the Gamma Knife Center at The Jewish Hospital – Mercy Health.

In 1991 Dr. Warnick helped launch one of the first stereotactic radiosurgery programs in the nation. Since then, he has performed more than 4,100 radiosurgery procedures for brain tumors and trigeminal neuralgia. He has published several landmark articles defining the role of radiosurgery in the management of brain metastases and was one of the pioneers in the development of frameless radiosurgery technology. Under his leadership, Mayfield was awarded membership into the prestigious International Gamma Knife Research Foundation (IRRF), a consortium of Gamma Knife centers of excellence. The IRRF recently published an article in the *Journal of Neurosurgery* demonstrating that trigeminal neuralgia patients treated with stereotactic radiosurgery within four years of diagnosis have better pain relief with lower risk. Dr. Warnick is also the principal investigator of an international study on trigeminal neuralgia to determine the relationship between biologically effective radiation dose and clinical outcomes.

Dr. Warnick served as Chairman of the American Association of Neurological Surgeons/Congress of Neurological Surgeons Section on Tumors from 2005 to 2007 and remains on the Advisory Board. He currently serves on the editorial board of the *Journal of Neuro-Oncology* and is an ad-hoc reviewer for the *Journal of Neurosurgery; International Journal of Radiation Oncology, Biology, and Physics*; and *World Neurosurgery.*

How long do I have to keep my dental charts?

The Supreme Court of Ohio recently upheld the constitutionality of the state's four-year statute of repose in medical and dental malpractice actions. A statute of repose is a provision that sets a time frame in which a legal right extinguishes. In other words, the statute of repose places an effective time limitation on when dental malpractice suits may be filed against a treating dentist. Ohio's statute of repose bars actions filed more than four years after the date of treatment, except in the case of those patients who are mentally infirm and with minors, in which case the four years begins to run upon emancipation.

Dentists had previously been instructed to retain patient records indefinitely to aid in the defense of a lawsuit. However, this favorable court ruling may help relieve dentists' record-keeping burden. There may be circumstances where a dental office must maintain records for a certain period of time; for instance, the retention requirement for Medicaid records (6 years) and Medicare records (7 years). Participating provider agreements also generally specify record retention requirements, as well as many professional liability insurance agreements. Dentists are encouraged to obtain guidance from legal counsel and their malpractice insurer prior to the disposal of any patient records and to seek guidance on establishing a new record retention policy.

TOP 10 ODA MEMBERSHIP BENEFITS OF 2021

1. We coordinated efforts to give out more than 2,000 PPE credits

DentaQuest, LLC made a \$200,000 donation to provide much needed personal protective equipment (PPE) to Ohio dentists during the COVID-19 pandemic. Working with OhioDDS partner Midway Dental Supply, DentaQuest provided Ohio dentists with the opportunity to request a credit of \$100 to order a selection of popular PPE. Midway also donated additional funds to provide credits to even more dentists. The ODA also distributed more than 10,000 free face shields to ODA member dentists.

2. We launched a Subcouncil on Diversity and Inclusion

The 2020 ODA House of Delegates passed a resolution recommending the creation of a Subcouncil on Diversity and Inclusion. This subcouncil was launched and got up and running in 2021. It serves to recruit and retain underrepresented demographics as members of the ODA and creates leadership development opportunities and training to grow and cultivate a broader pool of diverse leadership candidates.

3. We encouraged patients to get back to the dentist

The ODA created a radio and digital advertising campaign about the importance of seeing a dentist, particularly for those people who may have delayed receiving care during the pandemic. These ads played on ONN radio stations across the state.

4. We held virtual and in-person events

ODA Virtual Leadership Institute

 More than 200 people attended the ODA Virtual Leadership Institute, ODA's award-winning program developed to help all

ODA members become more successful and effective leaders.

- ODA Virtual Day at the Statehouse - At this year's virtual event, attendees contacted more than 80 legislative offices.
- New Dentist Zoo Day with the ODA The ODA Subcouncil on New Dentists hosted an event for new dentists and their families at the Columbus Zoo and Aquarium on July 17. 148 people attended the event, including 50 new dentists and their families.
- ODA Annual Session The 2021
 ODA Annual Session featured
 132 in-person CE credit hours,
 33 virtual CE hours, 130 vendors
 and thousands of dental professionals.

5. We testified in favor of non-covered services legislation

House Bill 344 was introduced by Rep. Jason Stephens (R-Kitts Hill) in June of 2021. This legislation would prohibit the ability for dental insurance companies to set prices for services that they do not cover in their plans. On Sept. 22, Dr. Sharon Parsons, a past ODA president, and David Owsiany, ODA executive director, testified before the Ohio House Insurance Committee in favor of House Bill 344.

6. We advocated on members' behalf to resolve dental insurance issues

We helped address issues that 22 individual members had with insurance companies and third-party payers, plus answered questions via phone and email from more than 200 members. We presented a written request to Delta Dental of Michigan, Ohio, and Indiana that calls for Delta Dental to take immediate steps to address its reimbursement rates. We

also wrote to Cigna Dental to express our concerns with a decision by Cigna to substantially reduce network dentists' reimbursement.

7. We offered a free online opioid course to help members meet the OSDB license renewal requirement

The Ohio State Dental Board is requiring dentists to complete two hours of continuing education on opioid prescribing and related issues. To help ODA members meet this requirement, we created a free online CE course.

8. Our regulatory compliance guide helped members ensure they are in compliance with Ohio regulations

Our regulatory compliance guide contains summaries, checklists and fillable forms to help you ensure your office is compliant with regulations, free as a benefit to members.

9. We continued to provide guidance on the COVID-19 pandemic

We have been monitoring the CO-VID-19 pandemic and how it affects dental offices and have provided up-to-date, reliable information as it becomes available.

10. We helped members save money through our ODA Services Corp.-endorsed partners

ODA members can save up to 30% on products and services through the ODA Services Corp. In 2021, the ODA Services Corp. continued to grow participation in our group purchasing organization, OhioDDS, and our in-office membership plan with DentalHQ. Oral & Oropharyngeal Cancer



Incidence and Mortality in Ohio (2018)1:

• 1,857 cases diagnosed • 407 deaths occurred

In Ohio, 65% of the oral and pharynx cancer tumors seen are late-stage tumors, which are much harder to treat and lead to a poorer prognosis.

Oral Cavity Cancer

Occurs in the oral cavity which includes the front tongue, floor of the mouth, inside the cheeks and ridge area around the mouth.

Risk Factors



Tobacco use: smoking cigarettes, pipes, cigars, snuff, chew, smokeless tobacco.



Alcohol use: especially when tobacco is used at the same time.



Exposure to HPV: the sexually transmitted, Human Papillomavirus.



Gender: The American Cancer Society attributes the higher incidence of oral cavity cancers to higher rates of alcohol and tobacco use by males.



Age: Most people who are diagnosed with oral cancer are 55 or older.





CHALLENGE:

Only about 1/3 of U.S. adults aged 30 and over who visited a dental practice in the last two years reported receiving an oral cancer screening.³

Oropharyngeal Cancer

Occurs in the back regions of the mouth—around the base of the tongue, back of the throat, and tonsils.

Risk Factors



Human Papillomavirus (HPV):

- Is the second most common sexually transmitted infection in the US.
- Is the primary cause of oropharyngeal cancers.
- Causes the most common HPV-associated cancer, surpassing cervical cancer.



Gender: More men of younger age are being diagnosed with HPV-related forms of oral cancer.



Age: HPV-related oral cancers are often diagnosed in people who are younger than age 55.







All dentists provide an oral cancer screening at each exam visit.

Policy Opportunities

Integration of Care:

- Automating reminder/recall for oral cancer screenings across healthcare organizations. | <u>LEARN MORE</u> >
- Provide incentives for workplace tobacco cessation programs. | <u>LEARN MORE ></u>
- Include HPV education in health education standards/high risk behavior curriculum in schools.
- Healthcare providers promote cessation counseling and referral to the Ohio Tobacco Quit Line, with emphasis on Medicaid enrollees and state employees.

Education & Workforce:

- Oral health professionals educate adolescent patients and their caregivers about HPV, tobacco and alcohol risk factors, and the benefits of HPV immunization in prevention of oropharyngeal cancer.
- Oral health professionals teach patients about symptoms of oral cancer and how to complete a self oral cancer screening.
- Oral health professionals administer vaccines. (The American Dental Association has offered its support to dentists who are seeking to administer vaccines, and The American Dental Hygienists' Association supports dental hygienists providing vaccines.)

Data, Payment and Quality: | LEARN MORE >

- Maintain and enforce Ohio's smoke-free workplace law, including prompt collection of fines for violations.
- Increase investment in mass media campaigns where evidence suggests that adult-focused cessation campaigns have the greatest impact on smoking prevalence and medical costs.
- Require reporting on performance of cessation metrics in Medicaid Managed Care and provider contracts.
- Monitor compliance of private health insurance plans with cessation coverage requirements.

> Access & Advocacy:

- Maintain the adult dental benefit in the Medicaid program.
- Remove barriers such a co-pays, prior authorizations, and quit attempt limits in cessation programs.
- Offer quit incentives in cessation programs. 4
- Raise awareness of cessation coverage among providers and tobacco users. 4
