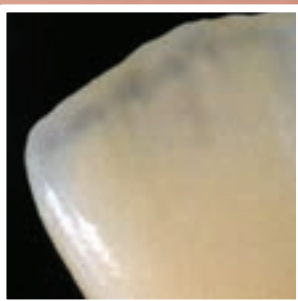
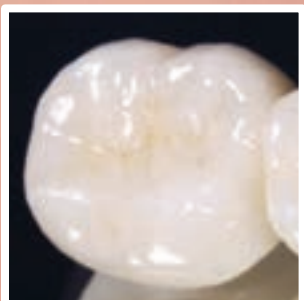

There is often a “blurb” in this publication about depression and resources available, but I doubt that many of you pay attention to it. We have all read that depression, suicide, drug overdoses, domestic and child abuse have all increased during this Coronavirus pandemic.

The possible reasons for depression among dentists have been well-documented. Dentists are prone to stress-related physical, mental and social problems. The average dentist spends most of his or her life confined to a small, sometimes windowless, 7 ft. by 9 ft. operatory, which is smaller than the cells in some of our penal institutions. The procedures performed are both physically and mentally taxing. As a result, strain, back troubles, circulatory disorders and fatigue are common. Dentists have a tendency to become both physically and emotionally “burned-out.”

Most dentists practice alone and do not have the opportunity to share and solve problems with their colleagues. Dentists are perfectionists. This trait is further emphasized in dental school where every restoration

must be perfect. Perfection is impossible. Dentists face enormous economic pressure. Between school loans and the cost of buying a practice, many dentists are more than one million dollars in debt, thus forcing many dentists to work even harder and longer hours.

Many patients are fearful or have anxiety when going to the dentist. Many patients will not accept “ideal” treatment due to financial constraints or low appreciation of quality dental care. The dentist ends

up emotionally carrying the responsibility for less than ideal results while the patient continues to express unrealistic expectations.

These problems are magnified during this pandemic. The Cincinnati Dental Society has been forced to cancel all social functions and some in person

continuing education courses. Emails, texting, and Zoom meetings do not replace them. Similarly, in our personal lives we do not gather with others and go out as we used to. Humans are wired for touch - a handshake, a pat on the back, a friendly hug, a peck on the cheek. Research has shown that when a person doesn't feel touch, the body registers the deficit as akin to starvation. Touch deprivation can trigger loneliness, anxiety and depression.

Unfortunately, dentists think of themselves as problem-solvers. The American Dental Association tells us many dentists suffering from depression feel they can solve the problem by themselves. Asking for help is a sign of weakness.

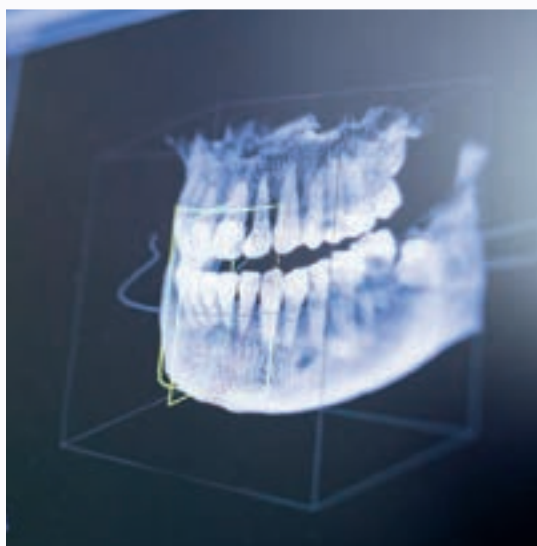
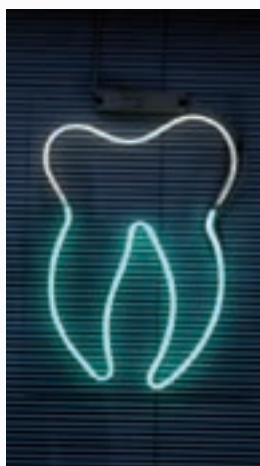
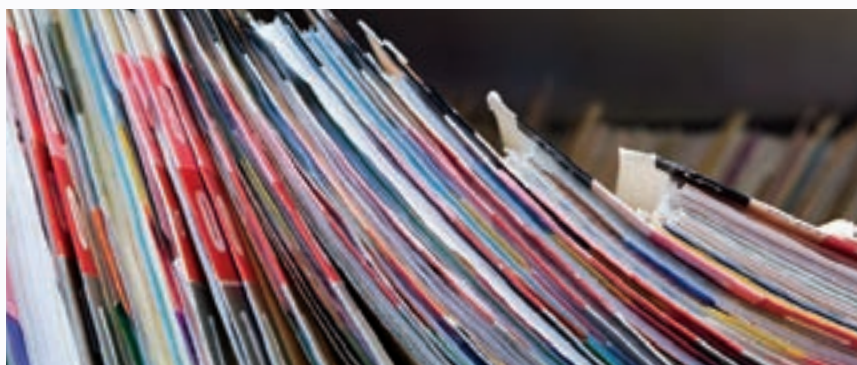

June 1, 2020 Council Meeting Minutes

Via Zoom

Secretary: Dr. Wayne R. Wauligman

Call To Order:

The June Council Meeting was held Monday, June 1, 2020 on Zoom. President Dr. Thomas Perrino called the meeting to order at 6:44 pm. The Order of Business and the CDS Mission and Antitrust Statements were presented to Council prior to the order of business via email from Executive Director Vicki Nixon.

Roll Call:

Members Present: Drs. Bennet, Brandt, Chopra, Dorr, Heck, Khetarpal, Murphy, Newby, Osterday, Parker, Perrino, Schaeffer, Wauligman and Yauss.

Members Absent: Drs. Bartish, Kelley and Poole

The February 3, 2020 Council Meeting Minutes were approved as posted without corrections.

President's Report by Dr. Thomas Perrino:

- Dr. Perrino reported Council member Dr. Scott Hudepohl resigned from Council and has moved and sold his practice.
- Dr. Mark Bronson will be asking for our support as he is running for the second vice president of the ADA. Campaigning does not start until October. A motion was made and unanimously approved (Wauligman/Schaeffer) to ask the Finance Committee to discuss giving up to \$10,000 for his campaign after he formally requests funds from the ODA as he begins in October. It was suggested he address this issue at the Subdistrict 9 Meeting.

Treasurer's Report by Dr. Andrew Dorr:

- Finance Committee meetings were held on Zoom on May 18 and 30 minutes on June 1 before the Council Meeting. The Finance Committee has reviewed and approved the 2019 IRS Form 990 and the April 2020 CDS Financial Reports. After discussion a motion (Perrino/Bennet) was passed unanimously to approve the 2019 IRS Form 990.
- As per Finance Committee discussion, it was recommended to take \$30,000 from the Discretionary Fund and place it into a Vanguard Dividend Growth Fund. The balance in that account (approximately \$1452.59) will be moved to the Operating Fund. It was moved by Andy Dorr and seconded by Ken Brandt to open the Vanguard Account with the \$30,000 placed in the Vanguard Dividend Growth Fund. It passed unanimously.

Executive Director's Report by Vicki Nixon:

- Regarding our programs and events, Vicki has been talking with the other executive directors about how to handle continuing education. The event centers have the means to do social distancing at meetings, but not at buffets. If we do conduct continuing education online, such as a webinar, it takes away from our focus and income. Because of having to move several of our seminars in our Full Series, we may have to refund members money if they are unable to attend the new date. The Shred-it Event was cancelled, and we will reschedule it when possible. A new schedule will be redone for the listing of seminars and member events this coming Fall and Winter.

CDS Committee Updates:

- *CDS Oral Health Foundation:* Dr. Ken Brandt announced the next Foundation meeting is June 15. The Patty Walter Walk in October at Lunken Airport more than likely will be cancelled, but that decision will be made at their next meeting. Dr. Brandt reported we are suspending the Leave No Vets Behind Program for the rest of this year. For now, we will finish existing cases and start no new ones.

June Council Meeting Minutes (continued)

- *Membership Committee:* Dr. Rick Yauss reported that as of April 30 fifty-four members were listed on the ODA's non-renewal report. Ten of those members are on the installment plan and are not counted as renewed until dues are fully paid. Several forgot and then renewed. Ten of those members listed have either moved out of state or retired. Dr. Yauss introduced eleven new Society members: Drs. Kevin Krupp, Alexandra Kulwin, Nishir Kumar, Brian Meister, Swapna Nadikuda, David Roemisch, Allison Shartzter, Rodney Stigall, Sophia Thankaraj, Raquel Ulma, and Nicole White. We accepted and welcomed them into our Society.
- *Program Committee:* Dr. Dennis Murphy listed some of the upcoming Fall meetings, listing the Emergency Medical Seminar on September 16, John McGill on October 29th if all goes well, the OSHA Seminar and others that will be re-listed and published. Watch the Bulletin. August 17 this the next Program Committee meeting. Discussion centered around the ODA Meeting for September 24-27, and they will need all the attendance and financial help we can give them.

ODA Updates:

- *Access to Dental Care:* No report
- *Annual Session:* No report other than to look for further announcements.
- *Dental Care Programs and Dental Practice:* Dr. Manny Chopra reported, as ODA Treasurer and Executive Committee member the following: Provided a legislative update. Reported that decisions relative to holding the 2020 ODA House of Delegates, resolutions and the ODA Annual Session are still being worked though. ODA net income is down.
- *ODA Membership:* Dr. Rick Yauss reported the ODA is proposing to align its dues structure to match the ADA with a three-year plan when coming out of a dental school. The first year it will be 0%, the second will be at 50% and the third will be 100% of normal dues. Dues payments are down from last year.
- There will be a new website up and running for the ODA starting this fall.
- *ODA Foundation Board:* Dr. Ken Brandt reported: Raffle tickets to support the ODA Foundation have been suspended. An online solicitation will be made to members for donations to the Foundation. There will be different levels of giving. Dr. Brandt is vice chairman of the Foundation and Dr. Jennifer Kale is Chairwoman.
- *ODPAC:* Dr. Matt Parker said there is nothing to report as there was no "Day at the Statehouse" this March.
- *Sub-council on New Dentists:* Dr. Chris Heck noted there will be a Top Golf event for new dentists at the Leadership event on March 27, 2021. A recruitment event this summer at the Columbus Zoo will probably be cancelled. There is a \$3,400 grant from the ODA to hold for example "life after residency", a new dentist formal, a luncheon, and/or a match event in conjunction with the ODA Session. There will be a conference call meeting in two weeks. Dr. Heck's term will end this year.

About the Course

Believe it or not, there is a large segment of the population who don't want to sit in the dental chair to have each problem tooth worked on individually but are still willing to pay significant fees for quicker and more efficient procedures. These patients and you, as their dentist, want the same things: restorations that look good, done as quickly and safely as possible and remaining trouble free over the long term. - Describe the current controversies in complete arch implant dentistry and understand the published literature that addresses these controversies.
- Understand the forces acting on contemporary implant restorations and recognize the specific clinical problems that these forces can cause, especially with accelerated loading.
- Implement clinical strategies to fabricate “same day” implant provisional restorations and final zirconia prostheses.
- Implement practical methods to assure safe, consistent and affordable implant esthetics, even with accelerated loading protocols.

About the Speaker

Dr. Edwin McGlumphy received his Bachelor of Arts degree in Chemistry from Washington and Jefferson College in 1981, and then earned his Doctor of Dental Surgery degree in 1985 from The Ohio State University College of Dentistry. After completing his General Practice Residency at the University of Texas, he returned to The Ohio State University College of Dentistry and was awarded his Master of Science degree and Certificate in Advanced Prosthodontics in 1988.

In addition to being clinical director of the team at ClearChoice Dental Implant Center in Columbus, Dr. McGlumphy is Professor Emeritus of the Restorative and Prosthetic Dentistry Division at The Ohio State University College of Dentistry where he was faculty for 32 years. He has published over 100 scientific articles related to implant dentistry and oral and maxillofacial surgery and is also an accomplished lecturer with more than 30 years' experience as a professional presenter. Dr. McGlumphy has also been a prosthodontist in private practice since 1988.

Dr. McGlumphy has been a member of the Academy of Osseointegration, the Omicron Kappa Upsilon Dental Honorary, and the Carl O. Boucher Prosthodontic Conference. In his spare time, he enjoys Ohio State Football and Basketball and completing projects at a small cabin in Hocking County.

Harold L. Crossley, D.D.S., M.S., Ph.D. is Professor Emeritus at the University of Maryland Dental School. A native of Rhode Island, Dr. Crossley received a Bachelor of Science degree in Pharmacy from the University of Rhode Island in 1964. He later was awarded the Master of Science (1970) and Doctorate degrees (1972) in Pharmacology. The University of Maryland Dental School in Baltimore awarded Dr. Crossley the D.D.S. degree in 1980. The liaison between the classroom and his part-time dental practice produced a practical approach to understanding the pharmacology of drugs used in the dental office.

Dr. Crossley has co-authored several articles and four books dealing with a variety of topics within the field of pharmacology. Other areas of expertise include the pharmacology of street drugs and chemical dependency. He serves on the Maryland State Dental Association's Well-Being Committee, is an active member of Phi Kappa Phi, Omicron Kappa Upsilon Honorary Dental Society, the American College of Dentists, International College of Dentists, and an honorary member of the Thomas B. Hinman Dental Society. He was the recipient of the 2008 Gordon Christensen Lecturer Recognition award presented by the Chicago Dental Society and the recipient of the 2012 Award of Distinction presented by the Academy of Dentistry International for his efforts in Continuing Dental Education. He has been a consultant for the United States Drug Enforcement Administration and other law enforcement agencies since 1974. Drawing on this unique background, Dr. Crossley has become nationally and internationally recognized as an expert on street drugs and chemical dependency as well as the clinical pharmacology of dental drugs.

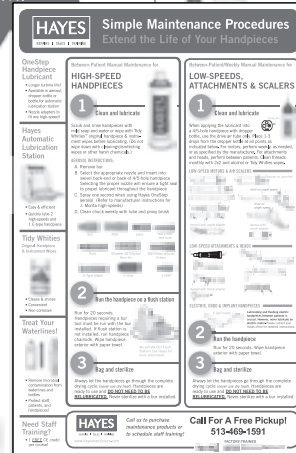

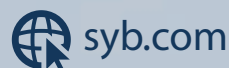
