would not be as successful as has been, and we would not have been able to help so many adults. Collectively, volunteer hours this year were just shy of 100!

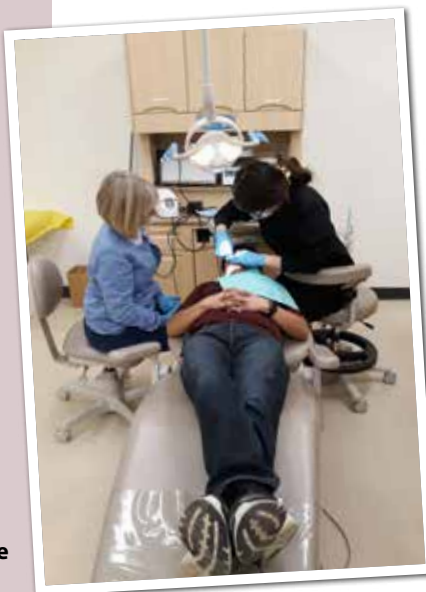

What came first? The chicken, or the egg? The proverbial question. In dentistry, what came first? The corporate practice model or the disdain for practice models outside classic solo practice? At the state level as well as the local level, I hear a lot of negativity towards corporate dentistry, DSOs and other models that fall in that general category. Some of it is warranted, some is simply fueled by fear, naivety or simply ignorance. If you personally know a small group of good dentists or specialists with multiple offices, how do you classify them? Just curious...

We are often asked or pushed in organized dentistry to combat this perceived evil. On more than one occasion, I have had members ask me directly "can't you do something about these corporate practices?" I generally punt and divert the conversation to other more worthwhile ventures including the repeal of McCarron-Ferguson Act at the federal level, the Non-covered Services bill at the state level or even the Student Debt problem. This usually doesn't satisfy the inquirer, but these are real things that can be changed and effect our profession and bottom line daily.

I worked for nearly five years in a corporate style practice model before buying my solo practice. I was a member of the tripartite, as was my employer dentist. While maybe not a true DSO with multiple owners/investors, it functioned as such. Shared business practices, marketing, brand, esthetic and culture throughout the multiple offices was the mission and the goal. Sometimes it worked really well, sometimes it fell a little short, but at the end of the day, I was still responsible for the care of the patient sitting in my chair. I tried to do it right, as did the practices themselves. Thankfully I was granted the autonomy to make my own clinical decisions, with the benefit of having a team of associates to bounce stuff off. Best of both worlds. There are unfortunately practices that have bad reputations, corporate or not. Thankfully in today's world, all you need is a google search to find that out. They will never be a threat to

you or me if they don't treat people well or they have shady business practices. Even if the dentist is a good one, they will eventually move on from these groups due to those very issues. On to bigger and better things. Maybe that's a solo practice.



I often get asked about if there are production quotas and how the employee contracts are structured. Are these practices predatory on associates and patients with the goal of maximizing the bottom line? Do they make you use a certain lab? Are they farming lab work out overseas? What about CE when you're working all the time? They take every insurance; how can we compete with that? The dentists that work in these practices aren't joining organized dentistry, how come? They are complex questions with many answers and every group is not the same.

There are practices that do the right things despite being a DSO or corporate. There are some that don't. The rise of DSOs has a lot to do with the lack of evolution of dental insurance, the desire to make dentistry more affordable to the under-insured, the expansion of the clinical team, desires to increase efficiency, sharing of overhead and convenience dentistry for the patient. I would love to be open 6-7 days a week and evenings. I would need to clone myself however. There is a market out there for those practices. So, if you aren't willing to take every insurance and work until 8pm, it's hard to argue with the model.

There are still dentists in those practices. Supporting the profession itself, whatever model it is, is what organized dentistry is about. We want to protect the private practice AND support new dentists and those working in a more corporate environment. We see a great deal of new grads going to corporate. This has a lot to do with the

The January Council Meeting Minutes were unanimously approved as posted.

President's Report: Dr. Christopher Heck

The 2019 Leadership Institute was well attended by dentists as well as dental students. Crowd favorites included: Updates from ODA staff, the match event and the availability of free CE. There are several ODA Committee openings; (Annual Session, Dental Education and Licensure, Ethics and Judicial Affairs, Finance and Leadership Development). Annual Session: Dr. Dennis Murphy

Finance: Dr. Manny Chopra

Income from the ODA investment account is expected to offset growing revenue deficits for at least the next 7 years. Additional ways to increase non-dues revenue are being explored.

Membership: Nothing to report.

ODA Foundation Board: Drs. Ken Brandt and Manny Chopra – raffle tickets are currently being sold.

ODPAC: Dr. Matt Parker – There are tentative plans to have a Capitol Club reception in Cincinnati soon.

The 2019 New Dentist Recruitment and Retention Event, held at the Columbus Zoo, continues to be extremely well attended. The Match Event for this year's Annual Session will take place on Friday evening. Dr. Christopher Heck will be the Chairman for the Subcouncil for 2020.

Old Business: Vicki Nixon

The reported shortage of dental hygienists appears to be a local-not statewide issue. Research into ways to increase availability in this area is underway.

New Business:

Dr. Manny Chopra discussed topics for our upcoming Day at the Statehouse; dental therapist and non-covered services legislation. Attendance at this annual event is strongly encouraged. A tele dentistry bill was recently passed. The specific details are forthcoming.

The CDS Strategic Planning Committee will meet on Saturday, April 13th at Kenwood Country Club.

Dr. Joseph Crowley summarized the current McCarren/Ferguson discussion occurring at the federal level. Competitive bidding of third-party payers is seen as a potential way to decrease the overall cost of health care. Also, being discussed is the potential dental benefit offered through Medicare. The Dental Practice Network is awarding a Cincinnati dentist for his/her humanitarian efforts.

Dr. Heck read the announcements. The meeting was adjourned at 8:30 pm.

stress of the Student Debt. They must get out and work and produce to pay those loans. I did too and that's why I started in corporate. Banks don't loan to unproven new grads to buy a practice. Private practice associateships in traditional settings are not as common as they once were, mainly due to economics and scope. It's becoming riskier to both the dentist and the associate to enter into these agreements without a substantial patient base and available dentistry. Mentorship in these instances is also dying.

Our corporate associates would also benefit from some 1-on-1 interaction with our members, especially if they aren't members! We need to figure out their needs, their desires and what organized dentistry can do to support them as dentists. It may be lobbying to control student debt, opening our practices sooner to taking on associates, offering more significant mentorship opportunities to young dentists or taking on a partner to benefit from the advantages similar to group practices.

It is not cut and dry or good vs. evil when talking about traditional practice vs. DSOs. It's the evolution of the profession. If you feel like you are getting hit by and losing to a corporate practice in your area, my suggestion is to look for practice management resources, and those provided by the ADA and ODA to evolve your business practices. Also, take good care of people. That's something that differentiates us all. I was always told that a good dentist will always be busy. I think there's some truth to that, but you also must keep up with your clinical skills, your business acumen and the quality of your clinical team. Good care trumps everything. Focus on those things, and not the disdain for the perceived threat of these newer practice models.

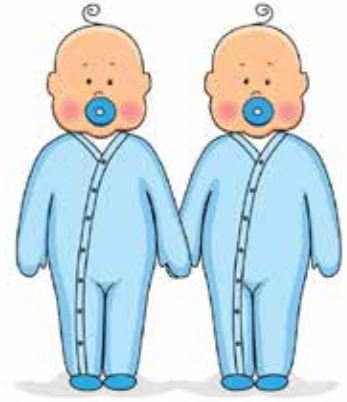

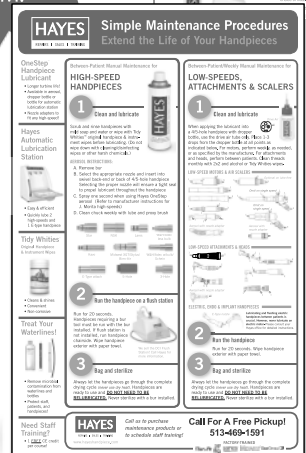
