

- 6) Taxes and inflation are going to rise for the foreseeable future. These are not the good old days of less than 3% CPI raises. Keep an eye on the office overhead and put that money into your retirement first.
- 7) **I'm old and tired** (and get off my lawn). I have pains in places that I didn't know existed and the sounds when I get up after laying down or sitting for too long are awe inspiring. Who knew?
- 8) Don't put off doing things till you retire. You'll never regret taking that vacation over sitting in the office making money. I've seen way too many friends retire only to develop dementia or other health issues way too quickly. Life is short and tomorrow isn't guaranteed.


Vicki's Voice

The Cincinnati Dental Society June 1, 2021 Council Meeting Minutes Via Zoom

Secretary: Dr. Wayne R. Wauligman

Call To Order:

The third 2021 Council Meeting was held Monday, June 7, 2021 via Zoom. President-elect Dr. Ruchika Khetarpal called the Council Meeting to order at 6:35 pm. The Order of Business and the CDS Mission and Antitrust Statements were presented to Council prior to the order of business via email from Executive Director Ms. Vicki Nixon.

Roll Call:

Members Present: Drs. Brandt, Chopra, Dagher, Dorr, Khetarpal, Murphy, Newby, Osterday, Perrino, Wauligman, Wessel and Yauss.

Members Absent: Bennet, Heck, Kelley, Parker, Poole, and Schaeffer Executive Director Ms. Vicki Nixon present.

A quorum was present. With no corrections, the March 29, 2021 Council Meeting Minutes were approved.

After an Executive Session to discuss Dr. Robert Buchholz's request to place an op-ed in the Cincinnati Dental Society Bulletin, Dr. Wauligman made a motion, seconded by Dr. Chopra, to allow or not allow his op-ed to be placed. Council voted unanimously to not allow placement of his op-ed in the Bulletin.

President's Report by President-elect Dr. Ruchika Khetarpal for Dr. John Bennet in his absence:

• Dr. Khetarpal announced honorees for the ODA Awards of Excellence; "Joseph P. Crowley, DDS Distinguished Dentist" and "Achievement" Awards.

Treasurer's Report by Ms. Nixon for Dr. Chris Heck in his absence:

- Ms. Nixon reported our 2020 IRS Form 990 is not yet finished by Barnes Dennig. When it is ready to review, we will schedule a meeting of the Finance Committee. It will then be ready for Council in September.
- Ms. Nixon explained that in the first five months of the year our income is down by thirteen percent, which is the result of not receiving all membership dues yet. We are not in bad shape as our expenses are down 50% at this point. Considering our Covid situation last year, our financial situation is good.

Executive Director's Report by Vicki Nixon:

- Ms. Nixon reported our new website platform is being developed, but it is unknown when it will be completed.
- Our June CDS Member Event is this week and a total of 32 have registered to date. We had to cancel one of the tables due to a lack of attendees signing for it. The other three tables are full. It will be held at the Hard Rock Casino.
- Dr. Khetarpal has selected as a venue for the January 7, 2022 "CDS New Year's Celebration and Awards Night", the Transept across from Washington Park and next to Music Hall.

June Council Meeting Minutes (continued)

CDS Committee Updates:

- *CDS Oral Health Foundation*: Dr. Brandt reported we have a June 14th meeting, but to date we have a good working relationship with the Cincinnati Health Network Dental Center. Dr. Kim Oberlander, who created and organized the seven-chair clinic, is the Director. The Foundation contributed \$35,000 to the Cincinnati Health Network Foundation to help cover the cost of small dental instruments and dental supplies. We also have an agreement and partnership with them for our "Leave No Vet Behind" program. We have begun referring veterans to their dental center. Ms. Nixon reported the need for a new copier as the old one is not repairable any longer. The cost of \$2200 is to be borne by the Foundation if approved at the June 14th meeting. It will benefit both the Foundation and the Society.
- Membership Committee: Dr. Rick Yauss reported the Committee is looking to schedule social events at different breweries. Financing for these events has been budgeted. We have a task force meeting June 23rd with the goal of recruiting dentists that fall into the category of diversity. Upon planning for such an event in 2022 we will come back to Council with a budget. Hopefully from the ODA we can secure a grant for this event. We have a new member joining the Cincinnati Dental Society, Dr. Neelum Jadeja.
- *Program Committee*: Dr. Dennis Murphy reported at the Committee's May 24th meeting, the evaluations received back from the three speakers were rated good to very good with Dr. Crossley as excellent. Dr. Crossley expressed a desire to come back so we will sign him up for 2023. Since lecturers are designing their seminars around three-hour programs, such as at the ODA Annual Session, we will be cutting our programs back to six hours from six and one-half. We have been contacted by Heather Ferris, director of the U. C. Blue Ash EFDA Program, that she is interested in being a sponsor for one of our continuing education programs in the future.

ODA Updates:

- Access to Dental Care: No report.
- Annual Session: Dr. Chopra reported that the Annual Session will be a hybrid meeting, but the House of Delegates will be held in person. In July, registration will be open. There is a position open on the Annual Sessions Committee.
- Council on Dental Care Programs and Dental Practice: Drs. Khetarpal and Dr. Chopra reported the council formed a special sub-committee to assist in developing an action plan (which is now being implemented) to address the ODA's concerns that Delta Dental needs to institute a fee increase. The council is working to submit resolutions to the 2021 ODA House of Delegates to address insurance companies' use of dentist rating systems- dentistry as essential healthcare. The council also put forth a recommendation of an ODA member dentist to serve on the Ohio Bureau of Workers' Compensation's Health Care Quality Assurance Advisory_Committee.
- *Executive Committee/Finance*: Dr. Chopra presented the ODA Treasurer's report. There is a zero percent change in revenue since last year, and expenses are down 7%, so the overall news is good. The Ohio State Dental Board has proposed some new anesthesia and sedation rules outlining requirements for general, deep, and moderate sedation. They are trying to finalize these rules which will include education and fees. The board has hired new legal counsel who is working on their backlog of cases. The non-covered services bill will be sponsored by Rep. Jason Stephens. There is no update news on the dental therapist issue at this stage. The last two legislative sessions saw no activity or sponsorship with any dental therapist bill. The Telehealth Bill is getting hearings and the Smile Direct Club is requesting new amendments to teledentistry.

The current law allows synchronous but not asynchronous (store and forward) communications. The e-Prescribe Bill, regarding Schedule II prescriptions, will require electronic prescriptions, and has currently passed in 23-24 states. The ODA is trying to get dentists exempt if they write less than a certain number of these prescriptions. The number suggested is fifty per year. Only two states have this exemption in place. The e-Prescribe bill will pass as it is becoming the policy throughout the country.

The North-east Ohio Medical University is planning to open a new dental school in Ohio in the Canton area. They have requested \$1 million per year over the next two fiscal years from the State of Ohio in the budget bill. It will be based upon the Community Health Center concept, where two years are spent in traditional learning with labs and didactics, and with the two following years practicing out in the community. It was formed to fill the need for having dentists in the underserved areas, thinking there are not enough dentists. The ODA informed them there is not a dentist shortage but rather a distribution shortage. On the issue of congressional redistricting, the State of Ohio will have a two-year map that will be released in August. It is thought it will be challenged at the Ohio Supreme Court. Dr. Matthew Messina has been reappointed as executive editor of "ODA Today". Speaker of the House of Delegates will be Dr. Denise Hering for 2022. Vice Speaker will be Dr. Kelly Roth. Dr. James Fanno, who has been our parliamentarian for fifty years, will be retiring. CDCPDP, the Council on Dental Care Programs and Dental Practice, before Covid, considered the idea of dentists giving flu shots to the public. The Council decided to recommend to the Executive Committee that it is not a good, feasible model due to extensive requirements. Therefore, it was not recommended to do this. But now, considering dentists being essential workers, the governor asked if dentists would do Covid vaccinations under emergency authorization. Since this time CDCPDP has been asked to evaluate the need and viability of dentists giving all types of vaccines. This would be in their offices and would not be mandatory. Dr. Chopra took a poll of the twelve CDS Council members present, and all indicated they would not offer vaccinations in their offices. Discussion then followed from Dr. Khetarpal's question about who can or should sponsor such events as the Leadership Institute. Dr. Chopra explained we need to fund for example, the Leadership Institute, as there are significant expenses involved. An issue not discussed at the latest meeting is when and if meetings can be held in person at the ODA. The Executive Committee has met virtually for the past year. Discussion then followed about the further need for wearing masks and if posting the mask sign is still required.

- *ODA Membership*: Dr. Yauss reported the last meeting was in May. The list of members with unpaid dues has been dwindling. The next meeting is in August and after that meeting there will be more to report.
- Sub-council on Diversity Inclusion: Dr. Khetarpal reported the Council has met and first defined who they are and to let others know they exist. Short- and long-term goals were discussed. They will pair up with the Women's Symposium at the ODA with speakers Dr. Canise Bean, Dr. Billie Sue Kyger and Dr. Kathy O'Loughlin, outgoing director of the ADA. This will help get the word out. A CDS Event will be planned.
- ODA Foundation Board: Dr. Brandt reported a fundraiser called the "Beard Chop" brought in about \$20,000 for the Foundation. The raffle system has a prize of free membership in the tripartite ADA, ODA, and local dental societies. The Foundation hopes to be back to normal next year. Dr. Chopra brought up Dr. Brandt's attendance on this Board has been twelve years and deserves congratulations for doing so. Council so thanked him.

• ODPAC: No report.

Old Business/New Business:

 Dr. Don Willen, Secretary of the Greater Cincinnati Dental Study Club, was putting together his CE for the Club in 2022, and he spoke with Mindy Franks, who handles continuing education at the OSDB. He found that in July, the Ohio State Dental Board will require study clubs to register through permanent sponsors, such as the dental societies, to achieve credit for their continuing education credits. For the CDS, this issue will be brought up first at the CDS Program Committee. Approval, if instituted, would go through this Committee, and involve applications and time and effort of the Committee members. Dr. Perrino noted the Ohio State Dental Board does not want to be in the business of approving courses. The ODA, as well as the dental colleges, also could approve continuing education credit for the study clubs.

Announcements:

- August 11, 2021 is the CDS only Subdistrict 9 meeting.
- September 13 is the next Council Meeting, live and in person at the CDS office.
- September 23 will be the joint Subdistrict 9 meeting for both CDS and Keeley delegates and alternates to the ODA House of Representatives.

Dr. Khetarpal adjourned the Council Meeting

First Course Description

Fasten your seatbelts! This lecture will be heavy on pictures with the goal of guiding the health care provider through the differential diagnosis, treatment, and management of commonly encountered oral soft tissue growths and ulcers in the dental office. Differentiating oral ulcers based on the clinical presentation, duration and location is imperative for appropriate management. Subjects include the differential diagnoses of white lesions including leukoplakia and lichen planus and red lesions including erythroplakia and geographic tongue. Emphasis on the clinical presentation of oral dysplasia or early cancer will be discussed. Diagnosis and treatment algorithms of lichen planus and other vesiculo-erosive conditions that can affect the oral mucosa will be presented. Biopsy techniques including biopsies for direct immunofluorescence will be reviewed. Diagnosis and treatment options for Burning Mouth/Tongue Syndrome will be discussed and tips on separating this entity from other causes of burning, including candidiasis and reactions to topical agents such as cinnamon, mints, and other agents. Differentiating oral ulcers based on clinical presentation, duration and location will be discussed, with special reference to aphthous ulcers and oral herpes. A review of HPV infections that affect the oral cavity both benign and malignant will be discussed. The presentation of oropharyngeal carcinoma in contrast to oral cavity cancer will be illustrated. And the role of oral health care providers in screening for these cancers will be discussed

- 1) How to develop a differential diagnosis for common oral growths.
- 2) Understand how color, shape and size can aid in identifying the growth.
- 3) Learn which lesions are normal variations and when to refer for biopsy.
- 4) Be familiar with the terminology of leukoplakia and erythroplakia and how to distinguish these entities from masqueraders.
- How to develop an organized approach to oral examinations and recognize the most common areas for oral cancer development.
- 6) Understand the role of HPV in cancer.

Prior to her current practice at Atlanta Oral Pathology, Dr. Susan Muller served on the faculty of the Emory University School of Medicine from 1995-2015, holding joint appointments in the Department of Otolaryngology, Department of Pathology, and the Winship Cancer Institute. Oral Health in Pregnancy & Children



Oral health <u>IS</u> health, yet oral health is either absent or underrepresented in conversations about overall health.

Oral Health is Essential in the Prenatal Period

- 1. Nearly 60 to 75% of pregnant women have gingivitis, which occurs when gums become inflamed due to changing hormones during pregnancy.¹
- Periodontitis (gum disease) has been associated with poor pregnancy outcomes, including preterm birth and low birth weight. ¹
- 2. Improved oral health of pregnant women can reduce children's future risk of tooth decay. Children are 3x as likely to have tooth decay if their mothers have high levels of untreated tooth decay.
- 3. Dental checkups and cleanings can reduce oral health problems in pregnancy.²
 - In 2018, fewer than 50% had a dental cleaning during their pregnancy. This number drops considerably for pregnant women of color and those with incomes below \$32,000/yr.
 - Only 35% of black pregnant women had their teeth cleaned.³

Oral Health is Essential to Children's Overall Health

- 1. Primary (baby) teeth are necessary to chew, smile, speak, and hold space for adult teeth.
- 2. Cavities in baby teeth need to be checked by a dentist.
- 3. Untreated tooth decay impacts childhood success, including academic readiness, absenteeism, career readiness, mental health and well-being.
- 4. Untreated tooth decay can lead to chronic pain and sleep and eating disorders.
- 5. Exposure to Adverse Childhood Experiences (ACEs) may be an important predictive factor for poor oral health. Early research shows exposure to 4+ ACEs was associated with a higher level of tooth loss and restorations at any age.

The Effects of Untreated Tooth Decay

- 1. Every year, thousands of patients visit a hospital Emergency Department (ED) for preventable dental conditions. These visits cost taxpayers, hospitals, and the government about \$2 billion each year.⁴
- 2. These patients are often treated with antibiotics and pain medications, which do not address the underlying dental condition and are an inefficient use of resources.
- 3. 4,158 children with Medicaid visited the ED for non-traumatic dental conditions in 2019.⁵
 - 48% had a follow-up visit in 7 days.
 - **57 %** had a follow up visit in 30 days.
 - **68%** had a follow-up visit in 180 days.
 - 32% had NO follow-up visit.

Oral Disease is a Burden for Children with Disabilities & Children in Poverty

- 1. Many children with disabilities are unable to cooperate with dental treatment and take medications which cause dry mouth (xerostomia), reducing saliva and increasing the risk of tooth decay.
- 2. Home health/personal care aides may not be trained in oral health, and there is a shortage of dentists trained to work with children with disabilities.
- 3. Low socioeconomic status is one of the strongest determinants of tooth decay in children.
 - **30%** of Ohio Appalachian children (ages 0-5) live in poverty.
 - **54%** of Ohio black children (ages 0-5) live in poverty. ⁶



- The well-child visit is an ideal time for applying fluoride varnish to children's teeth beginning at the age of primary tooth eruption through age 5. Fluoride varnish is crucial to tooth decay prevention.
- > Prenatal visits can be used as an opportunity to encourage pregnant women to seek preventive oral health care during pregnancy.
