
CANCELLATION POLICY

“Clues to Your Patients’ Health: The Most Prescribed Medications and How They May Impact Your Dental Treatment” and “Everything You Wanted to Know About Street/Pharmaceutical Drug Abuse and Their Impact on You, Your Family, and Your Dental Practice” - 6 CE Hours

“Clues to Your Patients’ Health: The Most Prescribed Medications and How They May Impact Your Dental Treatment”

Using commonly prescribed drugs as a starting point, this presentation explores the control of post-operative dental pain, and the antibiotic(s) of choice for oro-facial infections. What is the new FDA warning about codeine and tramadol in children? Why are NSAIDs more appropriate than opioids for treating post-operative dental pain. What are some concerns about NSAID prescribing in the geriatric population? Is antibiotic prophylaxis required for patients with an orthopedic prosthesis? What is antibiotic stewardship and how does it affect me.? Clinically relevant drug interactions with dental medications will be discussed.

At the conclusion of this course, the attendees will know:

1. How to minimize prescribing opioids for the control of post-operative dental pain
2. How to combine analgesics to maximize their effects.
3. Current recommendations for SBE and orthopedic prosthesis prophylaxis (**they have changed**)
4. A practical and useful pharmacologic approach for treating Oro-facial infections
5. Medications prescribed for Tardive dyskinesia and how they may interact with dental medications.

“Everything You Wanted to Know About Street/Pharmaceutical Drug Abuse and Their Impact on You, Your Family, and Your Dental Practice”

Opioids, alcohol, and marijuana are the big three in most discussions of substance abuse but what about the consequences associated with vaping, synthetic opioids/cannabinoids (K-2), cathinones (Bath Salts), toad licking, nutmeg, mushrooms, and over the counter (OTC) medications. The hallucinogens, amphetamines, and cocaine derivatives on the street are more potent than ever before. This lecture explores the new threats of substances that can be obtained via the internet, new information on the use/abuse of marijuana, the current climate of our opioid crisis, and their influence on you, your family, and your dental practice. This

lecture should be attended by all members of the dental team as well as spouses. **Must be 18 years or older to attend-no exceptions!**

At the conclusion of this course, the attendees will know:

1. The signs and symptoms of commonly abused prescription and illicit drugs in patients and adolescents.
2. What medications to avoid with the suspected drug abusing patient.
3. How to recognize and manage the doctor shopper.
4. How to manage the chemically dependent patient.

About the Speaker

Harold L. Crossley, D.D.S., M.S., Ph.D. is Professor Emeritus at the University of Maryland Dental School. A native of Rhode Island, Dr. Crossley received a Bachelor of Science degree in Pharmacy from the University of Rhode Island in 1964. He later was awarded the Master of Science (1970) and Doctorate degrees (1972) in Pharmacology. The University of Maryland Dental School in Baltimore awarded Dr. Crossley the D.D.S. degree in 1980. The liaison between the classroom and his part-time dental practice produced a practical approach to understanding the pharmacology of drugs used in the dental office. Dr. Crossley has co-authored several articles and four books dealing with a variety of topics within the field of pharmacology. Other areas of expertise include the pharmacology of street drugs and chemical dependency. He serves on the Maryland State Dental Association's Well-Being Committee, is an active member of Phi Kappa Phi, Omicron Kappa Upsilon Honorary Dental Society, the American College of Dentists, International College of Dentists, and an honorary member of the Thomas B. Hinman Dental Society. He was the recipient of the 2008 Gordon Christensen Lecturer Recognition award presented by the Chicago Dental Society and the recipient of the 2012 Award of Distinction presented by the Academy of Dentistry International for his efforts in Continuing Dental Education. He has been a consultant for the United States Drug Enforcement Administration and other law enforcement agencies since 1974. Drawing on this unique background, Dr. Crossley has become nationally and internationally recognized as an expert on street drugs and chemical dependency as well as the clinical pharmacology of dental drugs.

“Are Your Patients Getting Comfortably Numb? An Update and Review of Local Anesthesia Techniques and Pharmacology” – 6 CE Hours

Course Description

This lecture is designed for dentists and hygienists who wish to expand their understanding of the newest pharmacologic agents and delivery techniques of local anesthesia. A wide range of both maxillary and mandibular injection techniques will be reviewed and discussed. Safe and efficient block techniques for complete quadrant anesthesia of the maxilla and mandible, such as the Gow-Gates mandibular division nerve block and the Greater Palatine Canal maxillary division nerve block techniques, will be emphasized in the context of recognizing and anesthetizing accessory nerve pathways. The controversy surrounding the use of 4% anesthetic agents (articaine and prilocaine) for block anesthesia injections will be addressed, and management of possible complications and injuries related to the delivery of oral local anesthesia, such as paresthesia, are discussed. Use of alternative anesthesia modalities, such as topical anesthetic formulations (Oraqix, compounded topicals), the nasal spray delivery local anesthetic (Kovanaze), the anesthetic-reversal agent (OraVerse) and anesthesia buffering systems (OnSet and Anutra), and computerized delivery systems, to obtain either primary or secondary anesthesia are also presented. Dr. Budenz presents practical, useful information that can be directly applied to clinical practice in an informal, interactive style.

Upon completion of this lecture, the participants will:

1. Have a thorough understanding of the pharmacology of available local anesthetic agents, including their advantages, disadvantages, and safety profiles.
2. Have an appreciation of the anatomical basis of numerous local anesthetic injection techniques, and their advantages and disadvantages in practice.
3. Be knowledgeable about multiple techniques for obtaining profound anesthesia of both maxillary and mandibular teeth.
4. Be better able to assess and manage complications that may occur in the delivery of local anesthesia and be better able to avoid them when possible.
5. Be aware of new techniques and armamentarium recently available for the delivery of local anesthetics.



Dentists and dental hygienists attending this presentation should expect to return to their practices with an increased appreciation for the causes of local anesthesia failures and the knowledge to overcome these failures, and a greater sense of ease in recognizing and managing unexpected side effects and complications of local anesthetic injections. This will reduce the anxiety level of the practitioner and bring the practice another step closer to pain-free dentistry for each patient.

“Offensive Dentistry”

Let’s face it, sitting through a lecture about dental caries or caries risk assessment isn’t appealing (in fact it sounds downright boring). However, the science of clinical cariology is beginning to have an impact on restorative techniques and technology. *Streptococcus mutans* has more to fear than a rheostat now that we’re armed with salivary diagnostics and bioactive materials.

At the end of this course, participants should be able to:

- Intervene medically in the caries process.
- Control patient caries risk with focused therapeutics.
- Design restorations to minimize recurrent decay.
- Improve the prognosis of restorative treatment.

“Nobody Caries”

Sometimes it seems as though our patients don’t grasp the basic concept of home care. Other times our patients with impeccable hygiene develop rampant decay and we feel helpless because we can’t figure out what’s going on. The mouth is a remarkable environment that cariologists are finally beginning to understand, and so can you. Learn everything you didn’t know about plaque and the amazing organisms that make the mouth a wonderful place to work.

Learning Objectives

- Explain the mixed ecological approach to caries causation
- Apply Evidence Based and novel preventive therapies
- Quickly identify high caries risk patients before they develop disease

Dr. Harper currently serves on the AAOMS Committee on Anesthesia and Is a facilitator for the AAOMS Office Based Emergency Airway Management (OBEAM) Simulation Course. Dr. Harper also teaches the annual Medical Emergencies for the Dental Hygienist Course for the Cincinnati Dental Society

Deepak Krishnan, DDS – Dr. Krishnan is the chief of Oral Maxillofacial surgery at University of Cincinnati. He is an associate professor of Surgery at the College of Medicine there, where he teaches and practices. Dr. Krishnan obtained his dental degree from Bangalore University, India and trained in Oral and Maxillofacial Surgery at Emory University's College of Medicine in Atlanta, Georgia. He is a senior examiner for the American Board of Oral and Maxillofacial Surgery (ABOMS), a Fellow of the American College of Surgeons (ACS), and is the chief editor of Face to Face, the newsletter of the International Association of Oral and Maxillofacial Surgeons (IAOMS).
