Twenty-five years ago, I moved back to Cincinnati after several years of service in the United States Air Force Advanced General Dentistry program. I became an associate in Dr. Joe Crowley's practice on the west side of Cincinnati. I started to tag along to different events hosted by or planned by the Cincinnati Dental Society. Of course, after attending these events, I subsequently joined. That was my introduction to organized dentistry.

In the past, 20-25 years ago, organized dentistry and its membership flourished. I remember monthly meetings that were packed with dentists. CE courses were overflowing with attendees. I joined organized dentistry at that time because that is what you did. But I am glad that I did.

Organized dentistry benefits us all in so many ways. Whether it is through advocacy that protects us against unnecessary government intrusion or regulations or advocacy that fights against unfair insurance practices.

Organized dentistry programs allow us to serve others. The "Leave No Vet Behind" program which provides dental services to veterans who cannot afford treatment. This program was spearheaded by our own Dr. Ken Brandt who installed all the officers tonight. Thanks Ken. Other programs include "Give Kids a Smile" events and the ODA's relaunching of the dental options program.

As opposed to the past, in the present we are seeing dwindling membership. Dental seminars are half full. Dues revenue and continuing education revenue numbers are down. Finally, after several years of zoom meetings and no in-person events due to COVID, we are starting to see an uptick in the number of members who show up for in-person events.

We know that membership is in decline. Credibility and influence of organized dentistry is compromised if membership continues to fall.

Despite all these hurdles, it is imperative that we as society members need to ask a new dentist to a CE program, out to lunch, or to one of our Cincinnati Dental Society socials. Mentorship has been identified as a top reason why young dentists have joined organized dentistry. We need to reach out to younger dentists to get involved. Going to one event may lead to another event which may lead to involvement on a committee, which may lead to a position on council. Who knows it may ultimately lead you to take a turn as president. It only took me 25 years!

The future can be bright for organized dentistry. There is strength in numbers, and I would hate to lose that strength. Organized dentistry and our local society will continue to offer top-notch CE opportunities, philanthropic endeavors, and advocacy on our behalf.

In 2023 the ODA is focusing on insurance reform. Challenging the insurance

companies on the issue of non-covered services. The ODA continues to advocate for Medicaid improvement that could help our profession reach the most vulnerable patients with consistent care. This is advocacy that keeps the government out of our practices and insurance companies out of our pockets.

For a successful society in the future, we need involvement from everyone in this room (I know I'm preaching to the choir with this crowd).

Reach out to a non-member, a young dentist. Bring them to an event, invite them to lunch. It could be the nudge that is needed for a lifetime involvement in organized dentistry.

I look forward to serving as your president in 2023!




Course Description: This lecture is designed for dentists and hygienists who wish to expand their understanding of the newest pharmacologic agents and delivery techniques of local anesthesia. A wide range of both maxillary and mandibular injection techniques will be reviewed and discussed. Safe and efficient block techniques for complete quadrant anesthesia of the maxilla and mandible, such as the Gow-Gates mandibular division nerve block and the Greater Palatine Canal maxillary division nerve block techniques, will be emphasized in the context of recognizing and anesthetizing accessory nerve pathways. The controversy surrounding the use of 4% anesthetic agents (articaine and prilocaine) for block anesthesia injections will be addressed, and management of possible complications and injuries related to the delivery of oral local anesthesia, such as paresthesia, are discussed. Use of alternative anesthesia modalities, such as topical anesthetic formulations (Oraqix, compounded topicals), the nasal spray delivery local anesthetic (Kovanaze), the anesthetic-reversal agent (OraVerse) and anesthesia buffering systems (OnSet and Anutra), and computerized delivery systems, to obtain either primary or secondary anesthesia are also presented. Dr. Budenz presents practical, useful information that can be directly applied to clinical practice in an informal, interactive style.

Upon completion of this lecture, the participants will:

1. Have a thorough understanding of the pharmacology of available local anesthetic agents, including their advantages, disadvantages, and safety profiles.
2. Have an appreciation of the anatomical basis of numerous local anesthetic injection techniques, and their advantages and disadvantages in practice.
3. Be knowledgeable about multiple techniques for obtaining profound anesthesia of both maxillary and mandibular teeth.
4. Be better able to assess and manage complications that may occur in the delivery of local anesthesia and be better able to avoid them when possible.
5. Be aware of new techniques and armamentarium recently available for the delivery of local anesthetics.

Additional topics to be covered can be found on our website, www.cincinnatiadental.org.

Dentists and dental hygienists attending this presentation should expect to return to their practices with an increased appreciation for the causes of local anesthesia failures and the knowledge to overcome these failures, and a greater sense of ease in recognizing and managing unexpected side effects and complications of local anesthetic injections. This will reduce the anxiety level of the practitioner and bring the practice another step closer to pain-free dentistry for each patient.

Program:

The decisions we make regarding implant position and removable prosthetic restorations has a profound effect on the size of the intraoral volume. As we consider the timing and extraction, or non-extraction of orthodontic treatment, a major change in the size of the box will occur. The tongue being a hydrostat with a fixed volume which will not change, the shape can change, but not the volume, is the beginning of sleep disordered breathing which eventually can progress to sleep apnea. The patient changes their head posture to have a more adequate airway which directly affects TMJ mechanics leading to jaw joint and cervical dysfunction. Therefore, we, as dentists, control the size of the box and the medical wellness or morbidity because of our decision.

In this lecture, Dr. Diers will point out what he feels are our responsibilities as dentists for being good stewards of the intraoral space and tongue posture as it relates to tongue, TMJ, and sleep.

About the Speaker:

Dr. Diers graduated from the Northwestern University Dental School, where he was elected as a member of the Omicron Kappa Upsilon honorary dental society. He earned his M.S.D. (Master of Science in Dentistry) at the Indiana University Graduate School of Orthodontics and began his practice in 1971.

Dr. Diers has taken an active part in professional and civic organizations in the Greater Cincinnati area. He has served as president of the Ohio Valley Orthodontic Society, The Keely Dental Society of Butler County, the Greater Cincinnati Dental Study Club, and the Hamilton-Fairfield Junior Chamber of Commerce.

Dr. Diers is board-certified by the American Board of Orthodontics and a member of the American Association of Orthodontists, which sets the professional standards for orthodontists in the United States. He is a member of the consulting staff at Children's Hospital in Cincinnati and has been appointed Assistant Clinical Professor of Orthodontics at the Indiana University School of Dentistry and the Medical College of Georgia. As an expert on orthodontic developments, Dr. Diers has published articles in a number of journals and has spoken to gatherings of health-care professionals at universities and state societies around the country and the world.

As a result of his extensive research and training, Dr. Diers is able to treat most patients without removal of permanent teeth, by utilizing the latest state of the art procedures; Functional appliances for jaw growth, Self-ligating bracket systems for more efficient tooth movement, Invisible braces-Invisalign system, Accelerated orthodontics-treatment in 6-9 months, Sleep apnea appliances, and TMJ-treatment of jaw, joint problems.

Dr. Diers, through his research, has obtained two U.S. Patents: US 8,371,309 B2, Intraoral device upper airway disorders and US 7,833,013 B2. Device, method, and kit for determining orthodontic dimensions.


