As summer comes to a close, Fall begins and Winter looms, the long days of sunlight become fewer and fewer.

Active membership in the ADA has slipped to 57% in the past year. The ODA membership has been reduced to 61%. The Cincinnati Dental Society has also seen its membership shrink as well over the past few years. Continuing to trend this way could change our membership, our voice, in matters that affect all of us as dentists.

The ADA, ODA, and CDS offer our membership

- services, opportunities, and a unified voice in issues that impact the practice of dentistry. Some of the services far outweigh the cost of membership. Along with a long list of preferred providers who offer discounts on multiple goods and services the ADA on our behalf is seeking legislative solutions for dental workforce issues in many states.

The ADA has created two different recruitment flyers to put in our dental offices. These flyers could be used to present at a local career day or distribute at job fairs or other community events. These efforts are directed first at recruitment of dental assistants and dental hygienists and in addition to dental office managers and laboratory technicians.

I find advocacy to be the most important aspect of membership. The ADA advocates on our behalf by defending the profession, dental patients, and oral health before Congress and federal regulatory offices.

Recently the ODA has completed a regulatory compliance guide. The Guide, "Ohio Dentist Advisor: Your Guide to Regulatory Compliance" is

available now on the ODA website to download. This guide includes information on dental license requirements and C.E., infection control and hazard communication. Also, the DEA's requirement for DEA-registered practitioners to complete eight (8) hours of

opioid management. These are just a few of the compliance items that you can access for checklists and a fillable form to help ensure your office is compliant with regulations. The availability of invaluable information is part of membership.

President's Report by Dr. Andrew Dorr:

- The 2023 ODA Leadership Institute was enjoyed by all in attendance. This year's program included great breakout sessions and an informative membership update by the ADA.

- Dr. Dorr will develop a taskforce to investigate potential updates to component dues categories.
- The concept of a CDS-run dental assisting school was discussed and dismissed.

Treasurer's Report by Dr. Newby:

• The CDS's 2022 financial statements were reviewed. Two thousand twenty-two will close with an approximate \$16,000 deficit.

Executive Director's Report by Vicki Nixon:

- A request to publish an editorial in the CDS bulletin was discussed and denied.
- Upcoming celebrations, including the Jack Gottschalk, DDS Notable Service Award Celebration, were reviewed. Those unable to attend may elect to send in a donation to the Foundation. All members are encouraged to attend.

Honors Committee Report by Dr. Chris Heck:

• Congratulations to Dr. Thomas J. Perrino for his nomination for the ODA Achievement Award and to Dr. Khurram Khan for his nomination for the ODA Humanitarian Award.

CDS Committee Updates:

- CDS Oral Health Foundation: Dr. Brandt encouraged members (especially endodontists and oral surgeons) participation in the "Leave No Vet Behind" program. Invitations to the Jack W. Gottschalk, DDS, Notable Service Award Celebration were distributed.
- Finance: Dr. Newby reported as above.

"Offensive Dentistry"

Let's face it, sitting through a lecture about dental caries or caries risk assessment isn't appealing (in fact it sounds downright boring). However, the science of clinical cariology is beginning to have an impact on restorative techniques and technology. Other times our patients with impeccable hygiene develop rampant decay and we feel helpless because we can't figure out what's going on. The mouth is a remarkable environment that cariologists are finally beginning to understand, and so can you. Learn everything you didn't know about plaque and the amazing organisms that make the mouth a wonderful place to work.

- Explain the mixed ecological approach to caries causation.
- Apply Evidence Based and novel preventive therapies.

About the Speaker

Dr. Novy is the Chief Dental Officer of the Alliance Dental Center in Quincy, Massachusetts. The California Dental Association Foundation presented him with the Dugoni Award for "Outstanding contributions to dental education," and his office was the first to receive the title, "American Dental Association Adult Preventive Care Practice of the Year." He served on the ADA Council of Scientific Affairs from 2010 to 2014, and as chair of the CAMBRA coalition. In 2016 he was appointed the consumer advocate on the United States Food and Drug Administration Dental Products Panel.



About the Speakers

Jimmie Harper, Jr., DDS - Dr. Harper completed his dental training at the Ohio State University in 1979, followed by three years of active duty in the USAF as a General Dental Officer. He returned to the Ohio State University in 1982 to complete a four-year residency in Oral & Maxillofacial Surgery. After serving an additional four years in the USAF, Dr. Harper returned to Cincinnati where he has been in private practice for the past 33 years. Dr. Harper has been actively involved in resident education at the University of Cincinnati since 1990. He currently serves as a Volunteer Assistant Professor in the Division of Oral & Maxillofacial Surgery where he teaches a Medicine/Anesthesia course and a Surgical Anatomy course. 


