December 4, 2023 Council Meeting Minutes

Call To Order:

The December Council Meeting was held on Monday, December 4, 2023. President Dr. Andy Dorr called the meeting to order at 7:05 pm.

Roll Call:

Members Present: Drs. Bennet Jr., Brandt, Dagher, Dorr, Hanlon, Heck, Kelley, Murphy, Newby, Osterday, Parker, Poole, Schaeffer, Wauligman, Wessel, and Yauss.

Members Absent: Drs. Khetarpal, Perrino, and Stadiem.

Executive Director Ms. Vicki Nixon present.

A quorum was present. The November 6, 2023 minutes were approved as posted.

President's Report by Dr. Andrew Dorr:

• The report of the Nominating Committee, previously approved, was discussed. Two Council members, Drs. Wauligman and Wessel, volunteered to join the committee. Other Committee updates will be discussed at the February Council meeting.

Treasurer's Report by Dr. Newby:

• 2023 is anticipated to close with a \$25,000 deficit. Reserves will be used to cover this. The 2024 budget was discussed and approved (Khetarpal/Wauligman).

Executive Director's Report by Vicki Nixon:

• The CDS's New Year's Celebration and Awards Night is scheduled for January 12, 2024 at The Transept. In addition to installing the 2024 officers, members who have been out of dental school for 25 years, life members and recently retired members will be honored. Invitations will be mailed soon.

CDS Committee Updates:

- CDS Oral Health Foundation: Dr. Brandt discussed the expansion of our "Leave No Vet Behind Program" into Butler County. Several general dentists and an endodontist in this region have offered to volunteer their services. A limited number of orthodontic cases will also be treated through the "Foundation of Smiles" program. Please reach out to Vicki Nixon for more information. There are plenty of ways to give back through the Foundation. To date, more than \$1.8 million in donated goods and services have been provided to approximately 4,000 vets through this program. A contribution in the name of Dr. Patty Walter has been made to the Roberts Academy school-based dental center. The Jack Gottschalk, DDS, Notable Service Award Celebration is scheduled for May, 2, 2024. All members are strongly encouraged to attend.
- Finance: Dr. Newby reported as above.
- Membership Committee: Dr. Yauss welcomed two new members, Drs. Jaclyn Kachurak and Jinhui Li.
 A family focused event is planned for this Spring or Summer. Look for more details in May. The deadline for 2024 membership renewal is March 31st versus April 30th as in previous years.
- *Program Committee:* Vicki Nixon (for Dr. Murphy) reaffirmed the CDS will be offering only four full day courses in 2024. Other options will be available for 2024/2025 to fulfill licensure requirements.

December Council Meeting Minutes (continued)

ODA Updates:

- Council on Access to Dental Care: Nothing to report.
- Annual Session: Nothing to report.
- Council on Dental Care Programs and Dental Practice: Dr. Heck reported on OSDB efforts to review
 licensure rules and revising qualification for Board experts. The use of live patients for licensure exams
 is being phased out. The QUIP program will be discontinued. Alternate options are under
 consideration. Due to a dramatic increase in the number of Medicare Advantage Plans, more and more
 dentists will likely choose to become Medicare providers. The Non-Covered Services bill passed the
 Senate this fall.
- ODA Membership: Dr. Yauss reviewed the latest recruitment-retention statistics and the efforts
 underway to increase retention of recent dental school graduates. The CDS may apply for a grant from
 the ODA to fund our Potential Family event. Data from the 2023 Annual Session Meeting in Columbus
 was reviewed.
 - Subcouncil on Diversity, nothing to report.
- *ODPAC:* Dr. Schaeffer announced that while ODPAC membership is down, donations (in advance of the 2024 elections) are up.

Old Business/New Business: None.

2024 Recipient - Francie Wolgin, BSN, MSN

Francie is a graduate of the University of Cincinnati nursing program with BSN and master's degrees, and she has been an outstanding nurse for more than 40 years. She has impacted clients, healthcare professionals, students, and the community. Francie was at University Hospital after graduation. She then held both a nursing clinical faculty and management position at Duke University Medical Center in North Carolina.

She later relocated to Michigan and became an adjunct faculty at the University of Michigan and was System Leader for Education and Employee Development at Saint Joseph in Ann Arbor. Francie has also published numerous books, chapters and healthcare related articles and presented at national, regional, and local conferences.

Francie returned to Cincinnati and started a position as a senior program officer at Interact for Health. She was responsible for community health programs and later for school-based health center development over her twenty-two years at Interact for Health (1999-2021) until her retirement in 2021.

She has received numerous awards, most recently the National School Based Health Alliance's Lifetime Achievement Award (2023). In 2019, Francie received the Lifetime Achievement in Nursing Leadership Award from Mount St. Joseph University and was recognized as the nurse leader for the first Florence Nightingale Team Excellence in Nursing Award by the University of Cincinnati's College of Nursing, where Francie earned her master's degree. Under her leadership, Growing Well received the Florence Nightingale Team Excellence award in 2019. The University of Cincinnati's College of Nursing, where Francie earned her master's degree, recognized her for Outstanding Career Achievement in 2015 and named her a Distinguished Alumna in 1999.

School based health centers provide access to care for children and adolescents who have not been able to access care. Because the centers in the Cincinnati region have been developed as sustainable sites, they have become a reliable source of care for both students and community members. The centers are available to all children in their communities, including those experiencing

homelessness; those in foster care; those who have entered the United States as unaccompanied minors; as well as children whose parents struggle with missing work when they must leave work for appointments for the needed medical visits.

Francie has advocated for funding for dental programs at Interact for Health by demonstrating the impact of successfully modeled dental services in schools. She worked collaboratively with others to leverage that funding with other sources of funding to achieve the inclusion of dental services in new and existing school-based health center sites.

In Cincinnati, the school based health center work focused on primary care initially but as the families identified unmet dental and vision needs, Growing Well began to work on identifying sources to fund the startup of dental and vision services. With Francie's advocacy, Cincinnati has gone from very limited sources of dental care to five (and soon six) sustainable dental sites in Cincinnati Public Schools. The first site was Oyler Community Learning

Center's Delta Dental Center in 2013, and Aiken Dental was the last added in 2020. Roberts Academy will be the sixth site in Cincinnati Public Schools.

In addition, Francie has worked with multiple sites outside of the City to provide startup funding to expand and build comprehensive health services in schools. This expansion has included medical, dental and vision services at Fairfield School District. Hamilton School District, West Clermont School District, Middletown School District. Little Miami School District, Manchester Local School District, Braxton County Kentucky, and Mt Healthy Schools. The centers are taught sustainable models to ensure long term provision of care for students and their families. The school districts recognize the academic impact of meeting the health needs of students and the school-based health center work has become a strong partnership with the school districts.
